3. The person(s) will be considered for their distinctions and notable contributions to the Nogales educational system and to the community.
4. Nominations of close family members/relatives may not be made by members of the NHS Hall of Fame Board of Directors.
5. All nomination sheets and/or résumé submitted shall remain on file for three (3) years.
